



RICHACRE PRIVACY POLICY

HOW DO WE COLLECT YOUR DATA?

We collect information through your use of the Services. When you visit our site, including when you browse the Website and upload information and content, and/or download and use any Apps and/or Mobile Apps, we are aware of it and will usually gather, collect and record such uses, sessions and related information, either independently or with the help of third-party services.

When you sign up for our newsletter on our website, we also collect the Personal Information you provide us when you sign in to our Services via third party services such as Facebook or Google.

As part of the process, we collect personal information you give us such as your name, phone number and email address. Your personal information will be used for the specific reasons of marketing.

WHY DO WE COLLECT YOUR DATA?

We collect email addresses for our marketing campaigns and to be able to contact our Visitors and Users with general or personalized service-related notices and promotional messages. We do not share your personal information with third parties.

HOW DO WE STORE YOUR DATA?

Our company is hosted on the Wix.com platform. Your data may be stored through Wix.com’s data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall.
